

University of Vienna: privacy statement

The University of Vienna is the principal, i.e. the controller of data processing in the meaning of the General Data Protection Regulation (GDPR). In accordance with the controller's obligations to provide information, we request that you take note of the following statement.

Data processing is carried out for the following purposes:

- processing bookings for courses, including educational courses, provided or arranged by Universitätssportinstitut Wien (USI);
- organising local, national and international university competitions, and
- providing information about cancellations or changes to courses, and other organisational matters.

Cookies:

Cookies are used for the purpose of technical optimisation for your web browser. They are necessary for the proper technical functioning of the website and do not store any personal data. If you do not wish to accept cookies, please alter your browser settings accordingly. Please note that this may limit the functionality of the website.

Data are stored for seven years.

As the subject of data processing, in respect of your personal data you have the right to the following:

- Access;
- Rectification;
- Erasure;
- Restriction of processing;
- Data portability, and
- Termination of further processing, if the legal basis for processing is the controller's overriding legitimate interest or the data are processed for the purposes of scientific or historical research, or for statistical purposes.

You may also withdraw any consent to data processing that you have provided, at any time, without giving reasons. You also have the right to lodge a complaint with the Austrian Data Protection Authority (www.dsb.qv.at) if you believe data have been processed unlawfully.
